# AND HOW DO I LOCATE THE PROPERTY I.D. NUMBER – UPI ?

Beginning on January 2, 2013 all real estate related documents recorded in the Berks County Recorder of Deeds Office are required by County Ordinance No. 07-2012 to have the property PROPERTY I. D. number - UPI affixed to the document. The Recorder's office will verify the PROPERTY I.D. number — UPI prior to recording, if the number is not on the document or is not valid, the document will be rejected and a \$5.00 rejection fee per document will be charged. PLEASE NOTE THIS NUMBER IS AT LEAST 14 DIGITS IN LENGTH, 17 FOR CONDOS.

The fee for verification of PROPERTY I.D. number - UPI will be \$10.00 per document, per parcel.

#### Placement of PROPERTY I.D. Number - UPI

The **PROPERTY I.D. number - UPI** must be typed without dashes or other punctuation within the first four inches of the first page or cover page of each document along with the physical address of the parcel. **The PROPERTY I.D. number - UPI** may be obtained using the Berks County Assessment Parcel Search available at:


