Commissioners' Workshop Meeting Tuesday, May 29, 2007

I. CALL TO ORDER:

The Berks County Board of Commissioners met in regular session on Tuesday, May 29, 2007 at 10:30 A.M. in the thirteenth floor Board Room of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Judith L. Schwank called the meeting to order with Commissioner Thomas W. Gajewski, Sr., and Commissioner Mark C. Scott in attendance. Also present were County Administrator, William E. Dennis, Assistant County Solicitor Heidi Masano, Esq. and Chief Clerk Terry Styer. County Solicitor Alan Miller Esq. did not attend the meeting.

Commissioner Schwank opened the meeting with a moment of silence and the Pledge of Allegiance to the Flag.

II. PRESENTATION

Berks County Common Pleas Judge Peter Schmehl gave a brief presentation on Berks County Drug Court which began operations in January 2005. He described the court as a "marriage of treatment and the criminal justice system" and serves the community in a reality-based common sense approach to the drug and/or mentally ill, non-violent offender. He reported on the success rate of the court by showing the drop in recidivism of these offenders by being part of this program.

Commissioner Gajewski presented a Proclamation congratulating Berks PRIDE on recent accomplishments - George Vogel accepted the Proclamation on behalf of Carlos M. Martinez, Jr., a student at Reading High School, and a member of Berks PRIDE, who was unable to attend due to final exams.

Scott Rehr, Executive Director of the Berks County Prison Society / Berks Connections together with Sheila Bressler, Berks Coalition to End Homelessness Chair, Carolyn Bazik - Chair, Coalition Planning Committee, Karen Parish - Coalition Consultant discussed an upcoming workshop and the newly completed Strategic Plan to End Homelessness in Berks.

A. Adopt Resolution authorizing 2007 Budget Transfers in the amount of \$9,200. Bob Patrizio, Budget Director, presented the report.

A. Adopt a resolution to award a contract to operate **Business Development Services** in partnership with the Pennsylvania CareerLink ~ Berks County to the following service provider: **Educational Data Systems, Inc.
