Commissioners' Workshop Meeting Tuesday, May 25, 2010

I. CALL TO ORDER:

The Berks County Board of Commissioners met in regular session on Tuesday, May 25, 2010 at 10:30 A.M. in the thirteenth floor Board Room of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Mark C. Scott, Esq. called the meeting to order with Commissioner Christian Leinbach, and Commissioner Kevin Barnhardt in attendance. Also present were Solicitor Alan Miller Esq., Chief Operations Officer Carl W. Staples, and Chief Clerk Terry Styer.

Commissioner Scott opened the meeting with a moment of silence and the Pledge of Allegiance to the Flag.

II. DEPARTMENTAL REPORTS / REQUESTS:

Budget Department

A. Adopt a resolution authorizing 2010 Budget Transfers in the amount of \$19,744 and 2010 Appropriations in the amount \$2,831 per listing dated May 21, 2010.

Community Development

A.
