

Directions to Berks County Courthouse & Services Center

FROM:

ALLENTOWN / BETHLEHEM / EASTON - Interstate 78 or US 22 west, to PA 100 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

BETHEL - Interstate 78 (US 22) east, to PA 183 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

BOYERTOWN - PA 73 west to PA 12 west (Pricetown Road & the Warren Street Bypass), to 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

COATESVILLE - PA 82 north, to PA 23 west, to Interstate 176 north to US 422 west (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

EPHRATA - US 222 north, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

HAMBURG - PA 61 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

HARRISBURG - Interstate 81 north, to Interstate 78 (US 22) east, to PA 183 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

KEMPTON - PA 143 south, to Interstate 78 (US 22) west, to PA 61 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

KUTZTOWN - US 222 south to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

LANCASTER - US 222 north, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

LEBANON - US 422 east. Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

MORGANTOWN / ELVERSON - PA 23 west, to Interstate 176 north to US 422 west (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

NEW HOLLAND - PA 23 east, to PA 625 north. At the end of 625 (New Holland Road), turn right at the stop sign onto 222 Business north (Lancaster Avenue). Left on US 422 west (West Shore Bypass). Exit at the Penn Street interchange (first ramp, next exit); proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street;

turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

OLEY - PA 73 west, to PA 12 west (Pricetown Road & the Warren Street Bypass), to 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

PHILADELPHIA - US 422 west. Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

PINE GROVE - PA 501 south to Interstate 78 east to PA 183 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

POTTSTOWN - US 422 west. Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

POTTSVILLE - PA 61 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

STRAUSSTOWN - PA 183 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

TAMAQUA - PA 443 west, to PA 895 west, to PA 61 south, to US 222 south, to US 422 east (West Shore Bypass). Exit at the Penn Street interchange; proceed over the Schuylkill River on

the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.

WOMELSDORF - PA 422 east. Exit at the Penn Street interchange; proceed over the Schuylkill River on the Penn Street Bridge; east on Penn Street to Sixth Street (5th traffic light); turn left (north) on Sixth Street, proceed one block to the traffic light at Sixth & Court Street; turn right (east) on Court Street; the Courthouse is on your left, at 6th and Court, and the Services Center is next to the Courthouse, on the left at 6th and Reed. A public parking garage and surface parking lot are on the right, across Court Street.
