## **2018 Joint Citizen Police Academy Application**

Dear Applicant,

Thank you for your interest in the 2018 Citizen Police Academy. The Bern Twp. Police, the Muhlenberg Twp. Police, the Northern Berks Regional Police, and the Laureldale Police are combining forces to provide our communities an opportunity to go behind the scenes and experience the jobs of your police officers. We have organized a Citizen Police Academy (CPA) that will be informative, interesting, thought provoking and fun. There is no cost to attend the CPA.

The Citizen Police Academy (CPA) will be held every Tuesday night from 6:00 p.m. to 9:00 p.m. at the Muhlenberg Twp. Municipal Building at 210 George St., beginning February 13, 2018, and continuing every Tuesday for the next eight weeks. There will be an optional Weapons Familiarization class on Saturday, March 24th. The 2018 Citizen Police Academy is open to all residents of Bern Twp., Maiden creek Twp., Muhlenberg Twp., Laureldale Boro, Leesport Boro. and Ontelaunee Twp., who are 18 years of age and older.

Please fill out the application form and return it to the Police Department in the municipality where you live (Bern Twp., Muhlenberg Twp., Laureldale or Northern Berks Regional municipalities). Applications will be accepted from December 12, 2017 to February 2, 2018.

The class size is limited and applications will be processed by the order in which they are received. Acceptance to the CPA will be based on the date the application is received and the eligibility of the applicant. Applicants will undergo a criminal history check. Applicants will be considered if they have not had a prior felony arrest or have not been arrested for a misdemeanor in the last ten years, or be cleared by the discretion of the Chief of Police. The Bern Twp. Police Department, the Muhlenberg Twp. Police Department, the Laureldale Police Department and the Northern Berks Regional Police Department reserve the right to refuse an applicant for any reason deemed contrary to the purpose of the CPA.
