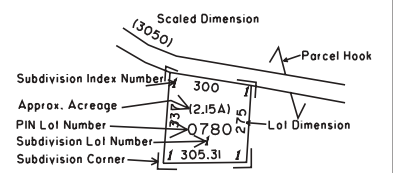

# PROPERTY MAP OF BERKS COUNTY PENNSYLVANIA

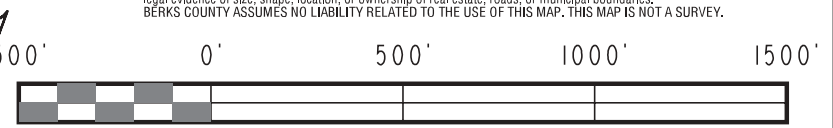

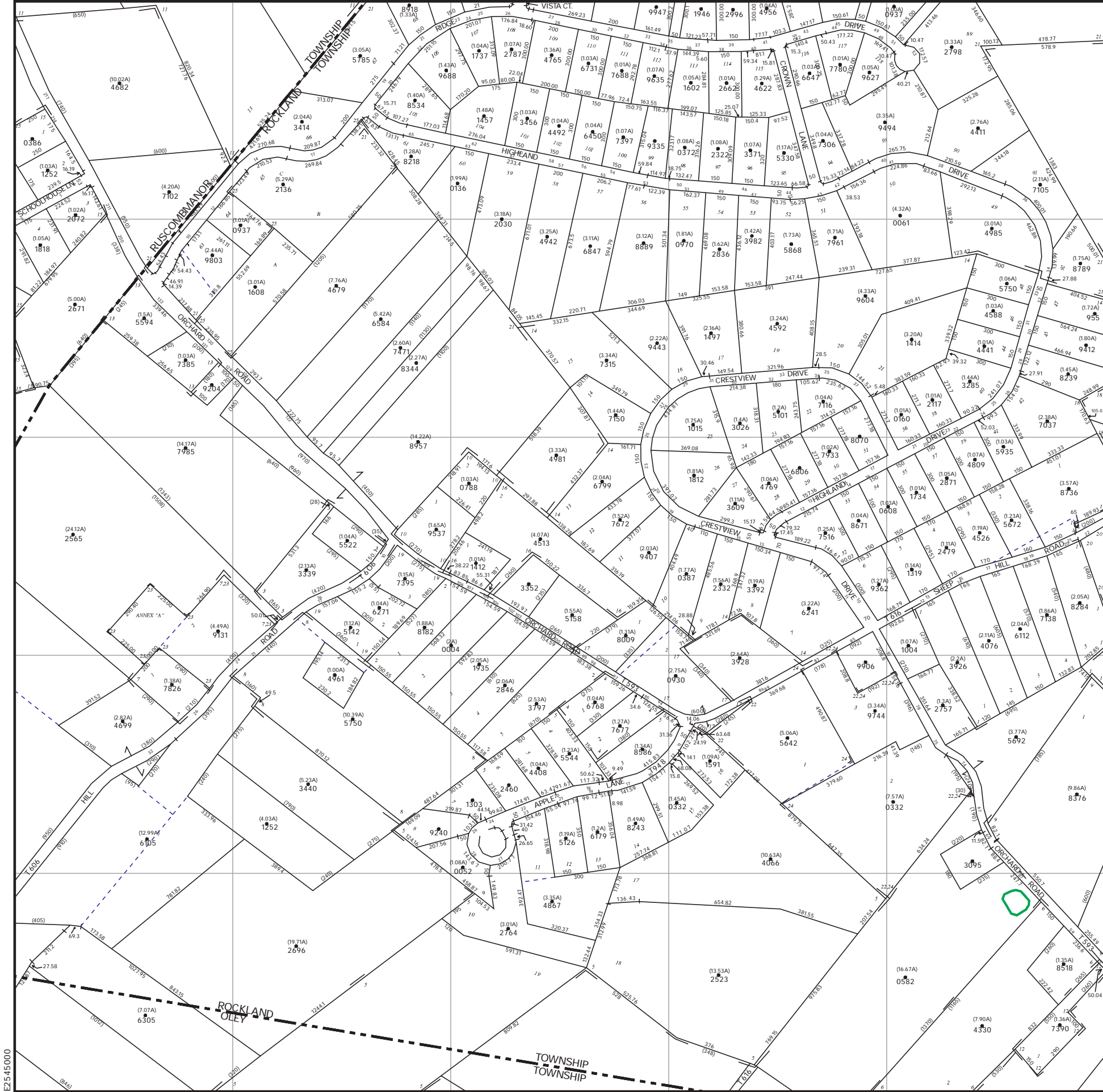
