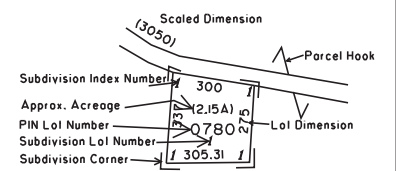

PENNSYLVANIA

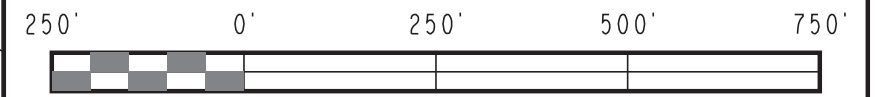

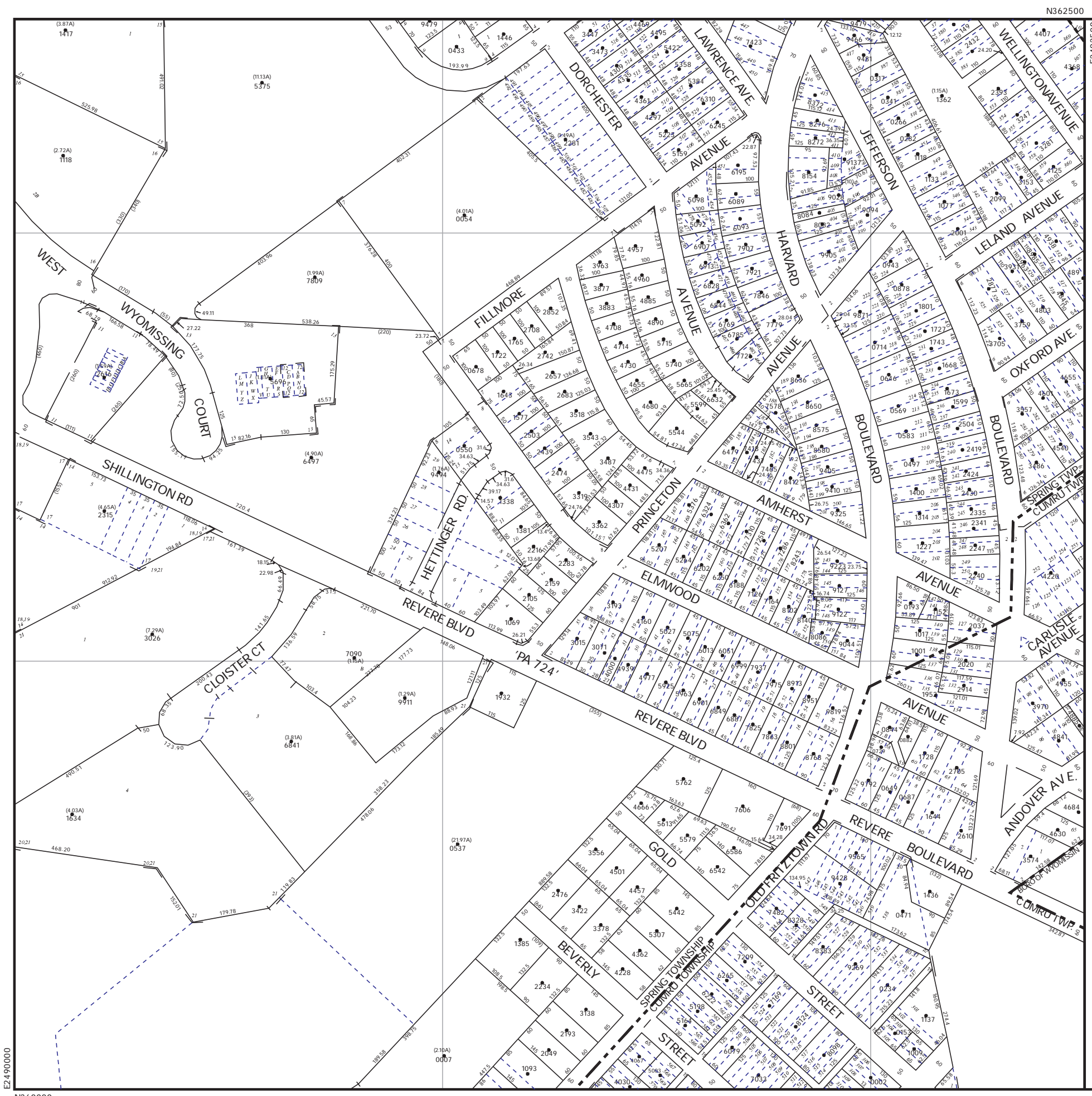
