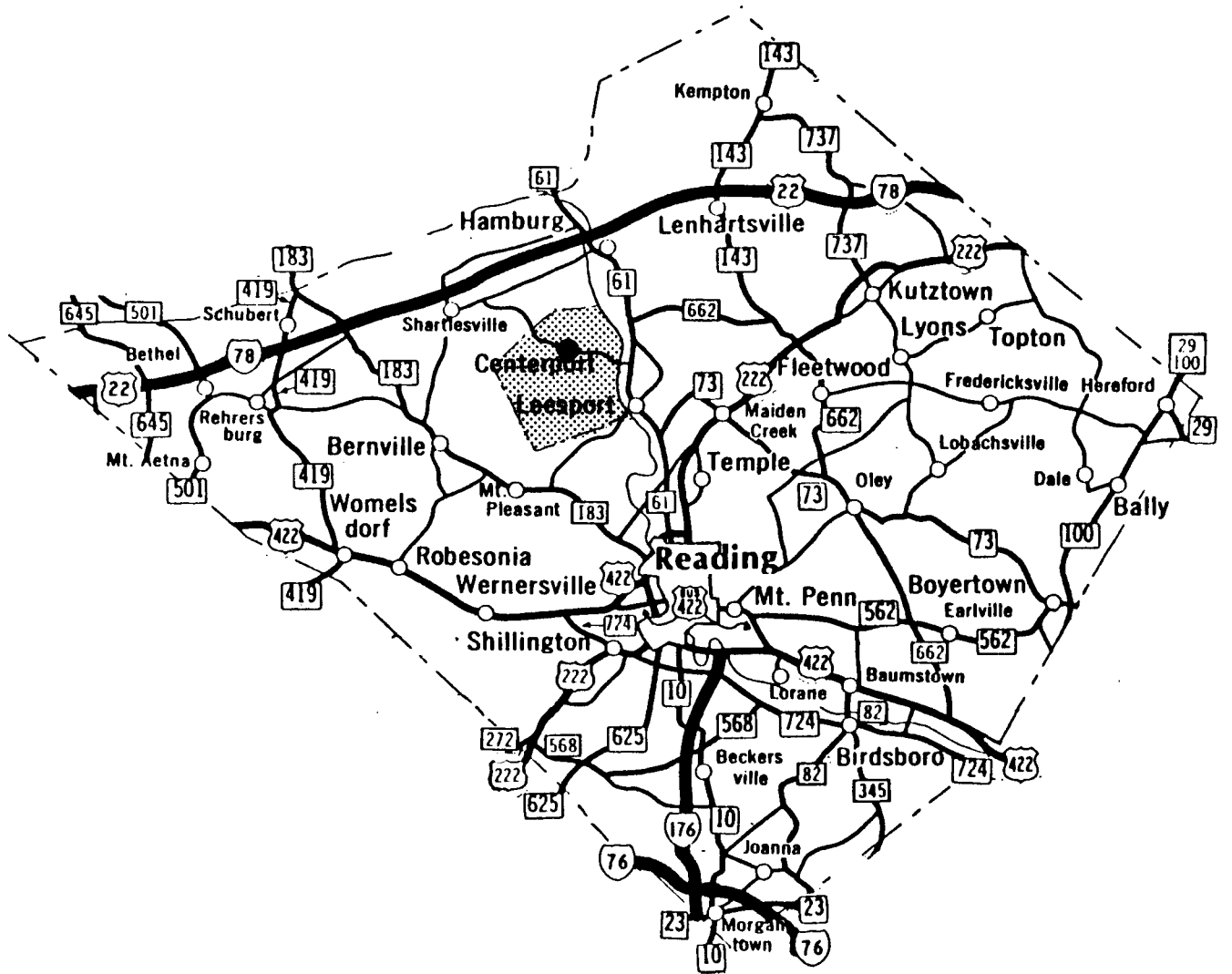


Figure 1.1 Location of Centre Township and Centerport Borough in Berks County.
