*The Prothonotary will not accept for filing any suit or action or order of court or entry of any judgment thereon or perform any service whatsoever unless the proper fee is submitted with the instrument to be filed.

CHECKS MADE PAYABLE TO “PROTHONOTARY OF BERKS COUNTY”

All checks returned for insufficient funds will be assessed a \$30.00 service charge.

*If you are presenting filings for more than one case in the same mailing, the Prothonotary requests a separate check for the filing fees for each case.

*If a claim for custody, partial custody or visitation is asserted in a divorce complaint or in a subsequent pleading, it shall contain the information required by PA. R.C.P.1915.15. An additional filing fee of \$15.00 shall be required per local rule 1920.31(a)(1)(c), plus \$8.50 **ACT 119 FEE** and \$5.00 PAF fee for a total of \$28.50.

***The maximum fee to be charged a political subdivision for any one of the services provided for herein shall be \$10.00 (42 P.S. §21075), and if applicable a \$5.00 PAF fee, a \$13.00 satisfaction fee, a \$40.25 JCP fee and tax.**
