Section One, Instructions to Bidders, Paragraph 1.3

1.3 Due/Opening Dates

1.3.1. The deadline for receipt of Bids is 1:00 P.M., local prevailing time, Tuesday, ~~September 28~~ October 5, 2021 (“Bid Deadline”). The County Controller’s time clock shall be considered the official time. **There will be no exceptions to Bid Deadline.** See Section One, paragraph 2.1 for detailed submittal instructions. We would recommend that you submit your proposal via a courier services, however if you opt not to and elect to physically deliver it personally you will need to leave it with County of Berks Security personnel, which must be done at minimum one hour prior to the time in which the proposals are due to ensure they have the appropriate time and resources to deliver it to the County Controller’s Office.

1.3.2. Bids will be opened publicly at ~~2:15~~ 3:15 P.M., local prevailing time, the same day, Tuesday, ~~September 28~~ October 5, 2021 (“Bid Opening”). As a result of limited public access to the Berks County Services Center the only manner in which to attend the bid opening will be through a live broadcast using Microsoft Teams. A summary of bids received (company name and bid price) will be posted on the Purchasing Department page of the County’s website (www.countyofberks.com).
