RESOLUTION NO. 2016-2

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF PENN, BERKS COUNTY, PENNSYLVANIA INCREASING THE FEE FOR A TAX CERTIFICATION

WHEREAS, by Ordinance 2007-02, enacted April 30, 2007, the Board of Supervisors of Penn Township authorized the tax collector of the Township to charge a fee of Twenty and 00/100 Dollars (\$20.00) for certification of tax information; and

WHEREAS, Ordinance 2007-02 further provides that the fee for tax certifications may be revised by adoption of a resolution for that purpose; and

WHEREAS, the Board of Supervisors desires to exercise the authority afforded it under Ordinance 2007-02 and adopt a resolution increasing the fee the tax collector may charge for certification of tax information to Twenty-Five and 00/100 Dollars (\$25.00).

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Penn, Berks County, Pennsylvania, that the elected or appointed Tax Collector of the Township of Penn, Berks County, Pennsylvania, is hereby authorized to charge a fee in the amount of Twenty-Five and 00/100 Dollars (\$25.00) for each certification of taxes by said Tax Collector.

FURTHER RESOLVED, that this Resolution shall take effect immediately, or as soon as legally permissible thereafter.




FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Penn Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.


