AN ORDINANCE OF UPPER BERN TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, CONFIRMING STOP INTERSECTIONS ESTABLISHED, AND STOP SIGNS HERETOFORE ERECTED, AT THE INTERSECTION OF PHEASANT DRIVE AND VALLEY ROAD (FORMERLY KNOWN AS "PENN VALLEY ROAD"); AT THE INTERSECTION OF SKYLINE DRIVE AND VALLEY ROAD; AT THE INTERSECTION OF OLD ROUTE 22 (FORMERLY KNOWN AS "MAIN STREET") AND SOUTH NORTHKILL ROAD; AT THE INTERSECTION OF OLD ROUTE 22 AND ROADSIDE DRIVE; AT THE INTERSECTION OF OLD ROUTE 22 AND BERGER LANE; AT THE INTERSECTION OF OLD ROUTE 22 AND MILL HILL ROAD; AT THE INTERSECTION OF WOLF CREEK ROAD (FORMERLY KNOWN AS "BERNVILLE-SHARTLESVILLE ROAD" AND FEICK DRIVE; AT THE INTERSECTION OF WOLF CREEK ROAD AND PHEASANT DRIVE; AT THE INTERSECTION OF WOLF CREEK ROAD AND NORTH BERNVILLE ROAD; AT THE INTERSECTION OF WOLF CREEK ROAD AND SOUTH BERNVILLE ROAD; AT THE INTERSECTION OF WOLF CREEK ROAD AND VALLEY ROAD; AT THE INTERSECTION OF WOLF CREEK ROAD AND SOUTH FOURTH STREET; AT THE INTERSECTION OF SHARTLESVILLE ROAD (FORMERLY KNOWN AS "SHARTLESVILLE/CENTERPORT ROAD) AND PEACOCK ROAD, AT THE INTERSECTION OF SHARTLESVILLE ROAD AND NAFTZINGERTOWN ROAD; AND AT THE INTERSECTION OF SHARTLESVILLE ROAD AND MILL HILL ROAD.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Upper Bern Township, Berks County, Pennsylvania, AND IT IS HEREBY ENACTED AND ORDAINED as follows:

Section 1. That two-way stop intersections are hereby confirmed, and official stop signs heretofore erected are hereby confirmed for vehicles traveling on Pheasant Drive in either direction at Pheasant Drive's intersection with Valley Road (formerly known as "Penn Valley Road"); for vehicles traveling on Skyline Drive in either direction at Skyline Drive's intersection with Valley Road; for vehicles travelling on South Northkill Road at South Northkill Road's intersection with Old

Route 22 (formerly known as “Main Street”); for vehicles travelling on Roadside Drive at Roadside Drive’s intersection with Old Route 22; for vehicles travelling on Berger Lane at Berger Lane’s intersection with Old Route 22; for vehicles travelling on Mill Hill Road at Mill Hill Road’s intersection with Old Route 22; for vehicles travelling on Feick Drive at Feick Drive’s intersection with Wolf Creek Road; for vehicles travelling on Pheasant Drive at Pheasant Drive’s intersection with Wolf Creek Road; for vehicles travelling on North Bernville Road at North Bernville Road’s intersection with Wolf Creek Road; for vehicles travelling on South Bernville Road at South Bernville Road’s intersection with Wolf Creek Road; for vehicles travelling on Valley Road at Valley Road’s intersection with Wolf Creek Road; for vehicles travelling on South Fourth Street at South Fourth Street’s intersection with Wolf Creek Road; for vehicles travelling on Peacock Road at Peacock Road’s intersection with Shartlesville Road (formerly known as “Shartlesville/Centerport Road”); for vehicles travelling on Naftzingertown Road at Naftzingertown Road’s intersection with Shartlesville Road; and for vehicles travelling on Mill Hill Road at Mill Hill Road’s Intersection with Shartlesville Road.


Section 2. That any motor vehicle failing to obey Pennsylvania law relating to said stop signs shall be subject to all penalties in accordance with the Pennsylvania Vehicle Code, 75 Pa. C.S.A. Section 101, *et seq.*;


Section 3. That any ordinance of Upper Bern Township inconsistent with the provisions of this Ordinance shall be repealed to the extent of any inconsistency; and,


Section 4. That this Ordinance shall take effect on the earliest date after enactment allowed by law.


